Our engineer attended an emergency call out today at Flat 14, Griffin Court, Trinity Close, Bath, BA1 1US. He found the source of the leak, which is before the flat's isolation valve, and therefore to fix the leak we need to isolate the water mains for that section of flats. We tried to reach out to Sanctuary to allow us access to the main stop tap for that section of the building, however we were unable to get in touch with anyone. If you would like us to carry out the repairs out of hours, please call us on 01225462598 and our OOH engineer will be able to attend and carry out the repairs if he is given access to the main stop tap.

Otherwise we will attempt getting in touch with you again on Monday to arrange repairs.

Our out of hours engineer attended the property on Saturday and carried out a temporary repair to stop the leak. Unfortunately he was unable to locate any stop taps externally or internally so he was not able to isolate to carry out replacement on the leaking pipework. We are sending one of our plumbers again today to try some alternative ways to access and isolate the pipe and then carry out the necessary replacement.

We've been trying to get in touch with Jesbir to locate the stop tap, but were unable to get hold of him. If anyone else is able to assist us with the information of where the external stop tap for the whole block is located, please let us know, as we were unable to locate it during our attendance on Saturday.
